MEMORANDUM AND ORDER
(Appendices to OI Report , Case 1-2001-007)

On October 31, 2001, as previously directed by this Licensing Board, the NRC Staff submitted to the Board and parties copies of OI Report 1-2001-007. The report as transmitted included the basic OI report but excluded appendices (exhibits) to the report.

In our Memorandum and Order (Telephone Conference Call, 10/31/01; Schedules for Proceeding), dated November 5, 2001, we established a discovery schedule extending from November 7, 2001 until February 8, 2002, but with no questions asked the Staff prior to December 4, 2001. By letter dated November 7, 2001, a copy of which was transmitted by e-mail to the Licensing Board, the Intervenors, CCAM/CAM, asked the Staff for copies of the appendices (identified in a "List of Exhibits") that accompanied the OI report. In a request for documents filed against the Licensee, dated November 7, 2001, CCAM/CAM also requested copies of these appendices from the Licensees.

The Licensing Board views the appendices or exhibits as integral portions of the OI Report that, as mentioned above, we had ordered to be circulated to the Board and

parties. Accordingly, they need not be included as CCAM/CAM discovery requests to the Licensee or Staff but instead should be furnished by the Staff to the Board and parties (in redacted form, if necessary) as soon as they are available for distribution.

The Licensing Board notes that, although the purpose of the OI investigation differs in some respects from resolution of the remaining issue before us at this time, the report appears to address the nature of the system used at Millstone-1 for locating fuel rods or assemblies in the spent fuel pool and for accounting for those rods or assemblies at all of the Millstone reactors.

Accordingly, the NRC Staff is directed, at its earliest convenience, to forward copies of the appendices to the OI Report (redacted, if necessary) to the Board and to all parties that have not yet been furnished those appendices.
