Who is RiskAudit?

Formed from GRS & IPSN as a management vehicle for subcontracts in EC.  
84 contracts; cumulative budget of \$75M, mostly in FSU/CEE.  
Want to broaden to other regions.

Work in FSU/CEE

Regulatory assistance (metodology & procedures)  
Support of indigenous TSOs (transfer analytical tools)  
Assist with/perform safety evaluations for licensing (esp. Kozloduy & Bohunice)  
(NRC comparing notes with GRS on safety evaluations in Ukraine)

Conclusion: Technology transfer only succeeds when recipients receive constant attention.

Purpose of visit: to exchange information on activities of RA and NRC, and views on developments, in FSU-CEE

Relationship between RA and Scientech: joint venture on SIP; want to deepen the relationship.

RA funding:

All but Russia: EC, TACIS  
Russia: EBRD (IDSAs & plant upgrades). Contract with GAN based on EBRD grants.  
Improved relationship after 1998.

TSOs & Status of SEC

SEC is doing serious technical work; Adamchik is using the results

SEC needs good engineering basis. Good in PRA & TH analysis & codes

"Russia has better technicians but Ukraine has better safety analyses."

TSOs could be strengthened with links to universities & training centers (self-sustaining).
