On November 8, 2001, Nuclear Regulatory Commission (NRC) management and staff met in Rockville, Maryland, with a representative of the FirstEnergy Nuclear Operating Company. The meeting, which was closed to the public due to the presentation of proprietary materials, was requested by the licensee in order to supplement their response to NRC Bulletin 2001-01, "Circumferential Cracking of Reactor Pressure Vessel Head Penetration Nozzles." The licensee has proposed deferring inspections recommended by the bulletin to their 13th refueling outage which is scheduled to begin in March 2002. The bulletin recommends that inspections be performed prior to December 31, 2001. A list of the meeting participants is included in the enclosure. There were no meeting handouts.

The licensee's justification to defer inspections recommended by the bulletin relied, in part, on the as-found condition of the reactor vessel head penetrations during the refueling outages of 1996, 1998, and 2000. The licensee's submittal of October 30, 2001, included proprietary photographs of the reactor vessel head taken during these outages. However, due to the poor quality of the photographs, the staff concluded that an independent assessment of the reactor vessel head penetrations could not be made. In an effort to demonstrate the structural integrity of the reactor vessel head, the licensee brought videotapes made during the refueling outages noted above. Thus, the meeting consisted of viewing videotapes and determining whether an independent assessment of the reactor vessel penetrations could be made. The staff made various comments concerning the quality of the inspections and their results.
