NOTICE OF ISSUANCE OF AMENDMENTS TO PROVISIONAL CONSTRUCTION

PERMITS AND NOTICE OF AVAILABILITY OF ATOMIC SAFETY

AND LICENSING APPEAL BOARD DECISION

Notice is hereby given that pursuant to a Decision issued by the Atomic Safety and Licensing Appeal Board on February 27, 1975, the Nuclear Regulatory Commission has issued Amendment No. 3 to Provisional Construction Permit No. CPPR-72 and Amendment No. 3 to Provisional Construction Permit No. CPPR-73 issued to the Tennessee Valley Authority for construction of the Sequoyah Nuclear Plant, Units 1 and 2, located in Hamilton County, Tennessee. The Decision modifies the construction permits to require compliance with the applicable federal and Tennessee water quality standards. Any decisions or actions taken by the Atomic Safety and Licensing Appeal Board in connection with this Decision may be reviewed by the Commission.

A copy of the Decision dated February 27, 1975, Amendment No. 3 to Provisional Construction Permit No. CPPR-72, Amendment No. 3 to Provisional Construction Permit No. CPPR-73, and the Tennessee Valley Authority's Final Environmental Statement are available for public inspection at the Commission's Public Document Room, 1717 H Street, N. W., Washington, D. C., and in the Chattanooga Public Library, 601 McCalley Street, Chattanooga, Tennessee 37403.

The Nuclear Regulatory Commission has found that the provisions of these amendments comply with the requirements of the Atomic Energy Act of 1954, as amended, and the Commission's regulations published in 10 CFR Chapter I and has concluded that the issuance of these amendments will not be inimical to the common defense and security or to the health and safety of the public.

The record developed in the public hearing in the above captioned matter modified in certain respects the contents of the Final Environmental Statement relating to the construction of the Sequoyah Nuclear Plant, Units 1 and 2, prepared by the Tennessee Valley Authority. Pursuant to the provisions of Section 51.52(b)(3) of 10 CFR Part 51, the Final Environmental Statement is deemed modified to the extent that the conditions relating to environmental matters contained in the Decision are different from those contained in the Final Environmental Statement issued February 1974. As required by Section 51.52(b)(3) of 10 CFR Part 51, a copy of the Decision which modified the Final Environmental Statement has been transmitted to the Council on Environmental Quality and distributed to the Environmental Protection Agency and other interested agencies and persons in accordance with Section 51.26(c) of 10 CFR Part 51.
