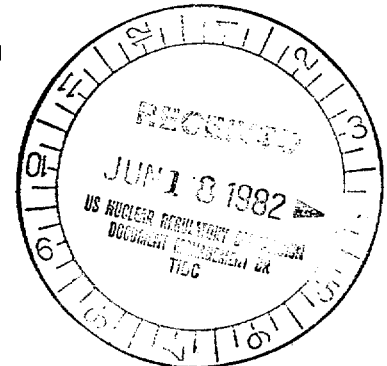

Subject: Outstanding Requests for Amendments to Sequoyah
Operating Licenses

This is to confirm our June 4, 1982, telephone conversation regarding outstanding requests for amendments to the operating licenses for Sequoyah Nuclear Plant, Units 1 and 2. The agreed upon action on each of the four items we discussed is shown below:

<u>Date</u>	<u>TS</u>	<u>Subject</u>	<u>Action</u>
June 29, 1981	16	Tests to qualify the reactor coolant system relief and safety valves.	Action has been completed.
December 14, 1981	24	Changes in Tech Specs to clarify the limiting conditions for the shutdown board room cooling system.	TVA will withdraw request.
March 25, 1981	12	Changes in Tech Specs regarding DNB Parameters, facility organization, and PORC composition.	TVA will withdraw and resubmit request.
December 31, 1980	8	Changes in Tech Specs regarding combustible gas limit actions statements, number of installed fire detectors, spent fuel storage capacity, and required ice condenser ice mass.	TVA will withdraw and resubmit request.

As we discussed, amendment fees paid by TVA will be returned for those amendment requests which are withdrawn.
