The purpose of this modification is to provide incremental funding in the amount of \$35,000, thereby increasing the obligated amount from \$1,563,000 to \$1,598,000. Accordingly, the following change is hereby made:

Section B.3, CONSIDERATION AND OBLIGATION-COST REIMBURSEMENT (JUN 1988) ALTERNATE I (JUN 1988), paragraph (b) is hereby deleted in its entirety and replaced with the following:

“(b) The amount presently obligated by the Government with respect to this contract is \$1,598,000.”
