The purpose of this modification is to provide incremental funding in the amount of \$50,000, thereby increasing the obligated amount from \$726,000 to \$776,000. Accordingly, the following change is hereby made:

Section B.3, CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), paragraphs (e) and (f) are hereby deleted in their entirety and replaced with the following:

“(e) The amount currently obligated by the Government with respect to this contract is \$776,000, of which the sum of \$732,075 represents the estimated reimbursable costs, and the sum of \$43,925 represents the fixed fee.

(f) It is estimated that the amount currently allotted will cover performance through November 15, 2001.”

A summary of obligations for this contract, from award through the date of this action, is provided below:

Total FY01 Obligation Amount	\$ 726,000
Total FY02 Obligation Amount:	\$ 50,000
Cumulative Total of NRC Obligations	\$ 776,000

This modification obligates FY02 funds in the amount of \$50,000.

All other terms and conditions, including the ceiling of \$1,728,494, remain the same.
