This letter refers to the inspection conducted on October 25, 2001, at your facility in Caldwell, Idaho. This inspection was an examination of activities conducted under the general license, pursuant to 10 CFR 31.5, as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your license. Specifically, the inspector reviewed Dairygold, Inc.'s possession, use and subsequent disposal of a Kay Ray density transmitter device containing cesium-137 as a sealed source. Within these areas, the inspection consisted of selected examination of representative records and interviews with personnel. At the conclusion of the onsite inspection, the inspection results were discussed with Mr. Dennis Agenbroad, Assistant Plant Manager.

Within the scope of this inspection no violations or deviations were identified; therefore, no response to this letter is required.
