NUCLEAR PLANT, UNITS 1 AND 2 (TAC NOS. M95144 AND M95145)
(TS 96-01)

Dear Mr. Kingsley:

The Commission has issued the enclosed Amendment No. 223 to Facility Operating License No. DPR-77 and Amendment No. 214 to Facility Operating License No. DPR-79 for the Sequoyah Nuclear Plant, Units 1 and 2, respectively. These amendments are in response to your application dated April 4, 1996, as supplemented by letters dated January 10, February 7, February 13, March 17, March 19, March 20, March 25, April 1, April 6, April 10, April 11, and April 18, 1997.

The amendments revise certain Technical Specifications and their Bases to allow for the conversion from Westinghouse fuel to Framatome Cogema Fuel (FCF). The enclosed amendments also incorporate new License Conditions 2.C.(25) and 2.C.(18) for License Nos. DPR-77 and DPR-79, respectively.

A copy of the staff's Safety Evaluation, which includes a listing of supporting documentation for this review, is also enclosed. Notice of Issuance will be included in the Commission's biweekly Federal Register notice.
