Subject: Issuance of Amendment No. 2 to Facility Operating License NPF-17 - McGuire Nuclear Station, Unit 2

The U. S. Nuclear Regulatory Commission has issued Amendment No. 2 to Facility Operating License NPF-17. Amendment No. 2 authorizes operation of the McGuire Nuclear Station, Unit 2, at 100 percent power (3411 megawatts thermal). The amendment also changes the license conditions related to environmental equipment and hydrogen control measures and adds a license condition requiring testing of reactor trip breakers. # MCGUIRE NUCLEAR STATION, UNIT 2

### FACILITY OPERATING LICENSE

AMENDMENT NO. 2 LICENSE NO. NPF-17

- 1. The Nuclear Regulatory Commission (the Commission) has found that:
  - A. The application, as amended, for license filed by the Duke Power Company (the licensee) complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's regulations set forth in 10 CFR Chapter I;
  - B. The facility will operate in conformity with the application, as amended, the provisions of the Act, and the regulations of the Commission;
  - C. There is reasonable assurance: (i) that the activities authorized by this operating license can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations set forth in 10 CFR Chapter I:
  - D. The issuance of this license amendment will not be inimical to the common defense and security or to the health and safety of the public;
  - E. The issuance of this license amendment is in accordance with 10 CFR Part 51, of the Commission's regulations and all applicable requirements have been satisfied;
- Facility Operating License NPF-17 is amended as follows:
  - A. Paragraph 2.C.(1) is hereby modified to read as follows:
    - (1) Maximum Power Level

The licensee is authorized to operate the facility at reactor core power levels not in excess of 3411 megawatts thermal (100% power) in accordance with the conditions specified herein and in Attachment 1 to this license. The preoperational tests, startup tests and other items identified in Attachment 1 to this license shall be completed as specified. Attachment 1 is hereby incorporated into this license.

- B. Paragraph 2.C.(6) is hereby modified to read as follows;
  - (6) Environmental Qualification (Section 7.8 of SER, SSER #4, #5, #6, #7)

The licensee shall environmentally qualify all electrical equipment within the scope of 10 CFR 50.49 in accordance with the implementation requirements of 10 CFR 50.49 (g).

- C. Paragraph 2.C.(10)e. 1) is hereby modified to read as follows:
  - 1) Prior to startup following the first refueling outage, the licensee shall:
    - a. Install two additional igniter units in the containment lower compartment and four additional igniter units in the containment upper compartment in locations acceptable to the NRC staff.
    - b. Provide a means acceptable to the NRC staff of verifying the operational status of the hydrogen control system in the main control room.
    - c. Provide the capability to actuate the Hydrogen Mitigation System from the control room.
- D. Paragraph 2.C.(12) is hereby added to read as follows:
  - (12) Reactor Trip Breakers (Section 7.2 of SSER #7)
    - a. By June 3, 1983, the licensee shall provide a program plan for conducting a life-test of the undervoltage trip attachment. The life-test program is to be reviewed by the staff before implementation.
    - b. The licensee shall modify the design of the automatic shunt trip of the main reactor trip breakers to install an independent fusing scheme. This modification shall be implemented on a schedule consistent with the schedule requirements of the NRC Salem Task Force generic program.
    - c. The licensee shall implement the reactor trip breaker and reactor trip bypass breaker testing and reporting as described in Table 1.

### NOTICE OF ISSUANCE OF AMENDMENT TO FACILITY OPERATING LICENSE

On March 3, 1983, the U. S. Nuclear Regulatory Commission (the Commission) issued Facility Operating License No. NPF-17 to the Duke Power Company (the licensee) authorizing operation of the McGuire Nuclear Station, Unit 2, (the facility) at reactor core power levels not in excess of 3411 megawatts thermal in accordance with the provisions of the License, the Technical Specifications and the Environmental Protection Plan with a condition limiting operation to five percent of full power (170 megawatts thermal).

The Commission has now issued Amendment No. 2 to Facility Operating License No. NPF-17 which authorizes operation of the McGuire Nuclear Station, Unit 2, at reactor core power levels not in excess of 3411 megawatts thermal in accordance with the provisions of the amended license. As part of this authorization, the amendment also changes the license conditions related to environmental qualification of equipment and hydrogen control measures and adds a license condition requiring testing of reactor trip breakers. The amendment is effective as of the date of issuance.

The McGuire Nuclear Station, Unit 2, is a pressurized water reactor located in Mecklenburg County, North Carolina, approximately 17 miles northwest of Charlotte, North Carolina.

The application for the license complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act) and the

Commission's regulations. The Commission has made appropriate findings as required by the Act and the Commission's regulations in 10 CFR Chapter 1, which are set forth in the amended license. Prior public notice of the overall action involving the proposed issuance of an operating license was published in the <u>Federal</u> Register on October 7, 1974 (39 FR 36037). The increase in power level authorized by this amendment and the conditions contained therein are encompassed by that prior notice.

The Commission has determined that the issuance of this amendment will not result in any environmental impacts other than those evaluated in the Final Environmental Statement since the activity authorized by the license is encompassed by the overall action evaluated in the Final Environmental Statement.
