INCIDENT AND EVENT INFORMATION: 2001 EVENT REPORTS (STP-01-082)

In All Agreement States Letter SP-00-081, dated November 29, 2000, we provided a copy of the Commission approved FY2000-2005 Strategic Plan which was based on the Government Performance Results Act (GPRA). In SP-01-012 (February 16, 2001) we included the most current set of national strategic and performance goals, and background information on the development of the materials performance goals for review and comment.

Under GPRA the Agency is required to prepare an annual performance report based on the Strategic Plan performance goals and target metric data. To meet the data needs of this report it is important that we have current and historical event reporting data.

We want to again thank and recognize the Agreement States for your actions taken to improve the timeliness and quality of material event information by providing better data to the Nuclear Material Events Database (NMED). Based on the current NMED data for 2001, historic averages have decreased. To assist us in further refining the data provided to Congress for the FY 2001 performance report we would appreciate your informing us as to whether you have entered all event data for FY 2001. If you find that you have not entered data for 2001, we would appreciate expedited data entry of the material events information into NMED.

If we can be of assistance in entering the data, please send the event report information to the Office of State and Tribal Programs and we will secure entry into NMED.

We appreciate your assistance in helping to prepare a complete set of national material event data that reflects the performance of our collective radiation programs nationally. We would appreciate your response within 30 days* from the date of this letter.
