Dear Mr. Williams:

On April 23, 1984, the Commission issued Amendment Nos. 103 and 97 to Operating License Nos. DPR-31 and DPR-41 for the Turkey Point Plant Units 3 and 4, respectively. These amendments provided new Technical Specification provisions and supporting basis which define limiting conditions for operation and surveillance requirements for radioactive liquid and gaseous effluent monitoring; concentration, dose and treatment of liquid, gaseous and solid wastes; total dose; and radiological environmental monitoring that consists of a monitoring program land use census, and interlaboratory comparison program.

Your staff has brought to our attention administrative errors on Technical Specifications pages 1-8, 1-9, 6-29 and Table 4.1-2 (Sheet 2 of 3). Typographical errors resulted in incorrect sequence of identification numbers on pages 1-8 and 1-9. Item "m" on page 6-29 and items 5 through 10 on Table 4.1-2 (Sheet 2 of 3) were inadvertently left off.

Enclosed are the corrected pages 1-8, 1-9, 6-29 and Table 4.1-2 (Sheet 2 of 3). We have verified that the errors do not affect the amendments, the supporting Safety Evaluation and the corrections are consistent with the amendments. Please use the enclosed instruction sheet and replace the pages identified above in Appendix A of Facility Operating License Nos. DPR-31 and DPR-41 with the corrected pages and table.

Please accept our apologies for any inconvenience these errors may have caused.
