SUBJECT: TURKEY POINT UNITS 3 AND 4 - ISSUANCE OF AMENDMENTS RE: REPLACEMENT OF CURRENT TECHNICAL SPECIFICATIONS WITH REVISED TECHNICAL SPECIFICATIONS (TAC NOS. 63038 and 63039, 55915 and 55916, 55384 and 55385, 71864 and 71865)

The Commission has issued the enclosed Amendment No. 137 to Facility Operating License No. DPR-31 and Amendment No. 132 to Facility Operating License No. DPR-41 for the Turkey Point Plant, Units Nos. 3 and 4, respectively. The amendments consist of changes to the Technical Specifications in response to your application transmitted by letter dated June 5, 1989, as supplemented July 12, 1989, November 3, 1989, February 13, 1990, May 1, 1990, June 21, 1990 and July 20, 1990.

These amendments replace the entire current custom Technical Specifications with a set of revised Technical Specifications (RTS) which are based on the standard Technical Specifications for Westinghouse-designed plants. The RTS include added surveillances, action statements, and an improved user-friendly format, as well as other technical improvements which have been developed as a result of many years of industry operating experience and analyses since the initial TS were licensed for Turkey Point. The RTS impose many additional requirements and actions for surveillance, testing, and maintenance of equipment, and taken as a whole, are believed to represent a significant safety improvement for the operation of Turkey Point units 3 and 4.

The RTS issued with this amendment also serve to close out, for Turkey Point units 3 and 4, a number of generic technical issues which have been of concern to the NRC staff at nuclear plants in the U.S. These include the following:

1. Generic letter 84-15 (TS to reduce cold fast test-starts of diesel generators, TAC Nos. 55915 and 55916).
2. Generic letter 85-09 (TS for testing of shunt trip reliability, Salem ATWS Item 4.3, TAC Nos. 55384 and 55385).
3. Generic letter 87-09 (Applicability of Limiting Conditions for Operation, TAC Nos. 71864 and 71865).
4. Letter dated 11-28-78, Schwencer (NRC) to Uhrig (FPL) (TS for containment purge).




