The Nuclear Regulatory Commission is located in a two building complex at the White Flint Metro Station, in Rockville, Maryland. One building is an 18-story Federal building, the other is a 10-story building leased by the General Services Administration. NRC fully occupies both buildings. To date, we have placed concrete "Jersey" barriers around the Complex. We expect to eventually replace them with more permanent security bollards when funding is established. The only other physical security improvement planned is to install a guard booth at either end of our front plaza to afford a measure of comfort for our security guard force during inclement weather (sketch of booth is enclosed).

As additional projects are identified, we will submit them to the National Capital Planning Commission.
