Dear Mr. Everson:

This is in reference to your application dated November 27, 2001 requesting to renew Nuclear Regulatory Commission License No. 37-28639-01. In order to continue our review, we need the following additional information:

1. Your application does not contain the information needed to support your request for fixed gauge activities. Please resubmit your application using the guidance in NUREG-1556, Volume 4, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Gauge Licenses" (enclosed). The checklist in Appendix B in NUREG-1556, Volume 4 contains procedures that are acceptable to the NRC and may be used to submit your response. Please photocopy Appendix B, write the name of the Radiation Safety Officer and the sealed source and device model numbers in the appropriate boxes, checkmark (✓) the appropriate boxes, and send this in with your response to this letter.
2. The sealed source and device model numbers listed in your renewal do not match the Sealed Source and Device Registry. For example, there is no LFE Model PM5000 or Accuray Model 1180. According to your Device Window Replacement Procedure, you list LFE Models SCL-77A and SU-P77A. These two latter devices are registered and copies of their registration are included in this letter. Please check the labels on the gauges to be certain which models you possess. Please provide the sealed source and device model numbers in the first section of Appendix B.

3. Section 8.7.1 of NUREG-1556, Volume 4 states that a Radiation Safety Officer (RSO) should have successfully completed the gauge manufacturer's or distributor's course for users or for RSOs or an equivalent course that meets Appendix G criteria. In addition, the NRC can only list one RSO on the license. Please indicate if you or Ms. Olszewski has had this type of training. If neither of you have had this type of training, you can name Mr. Charles Morgan as the interim RSO since he is already listed on the license as an Authorized User. Thus he has had the required training.
4. Section 8.10.3 of NUREG-1556, Volume 4 provides a table for Record Maintenance. In your application you indicated that inventory records would only be maintained for 2 years. Please ensure that you follow the Record Maintenance requirements described in NUREG-1556, Volume 4.

In accordance with 10 CFR 2.790, a copy of this letter will be placed in the NRC Public Document Room and will be accessible from the NRC Web site at <http://www.nrc.gov/NRC/ADAMS/index.html>.

In order to continue prompt review of your application, we request that you submit your response to this letter within 30 calendar days from the date of this letter.
