On December 3, 2001, the NRC staff completed a review of the performance indicators of the LaSalle County Station as reflected in the performance indicators for the third quarter of 2001. Our review identified that LaSalle Unit 2 crossed the threshold from Green to White for the unplanned scrams per 7000 critical hours performance indicator. Therefore, we plan to conduct supplemental inspection procedure 95001 during the week of December 10, 2001, to better understand the causes contributing to this issue.
