Dear Mr. Cooper:

In a telephone conversation on December 3, 2001, Mr. Russel Bender, Licensed Operator Requal Supervisor, and Mr. Hironori Peterson, Senior Operations Engineer, made arrangements for the NRC to inspect the licensed operator requalification program at the Palisades Nuclear Power Station. Mr. Bender has been advised of this request and provided with the name and address of the NRC lead inspector assigned to this inspection.
