AMENDMENT TO FACILITY OPERATING LICENSE

Amendment No. 30 License No. DPR-41

- 1. The Nuclear Regulatory Commission (the Commission) has found that:
 - A. The application for amendment by the Florida Power and Light Company (the licensee) dated August 9, 1978, complies with the standards and requirements of the Atomic Energy Act of 1954, as amendment (the Act), and the Commission's rules and regulations set forth in 10 CFR Chapter I;

 - C. There is reasonable assurance (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations;
 - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
 - E. The issuance of this amendment is in acordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.
