SUBMITTAL OF THE WHITTAKER SITE DECOMMISSIONING PLAN

Dear Dr. Lardiere:

This letter provides a summary of the November 27, 2001 meeting to discuss the submittal of Whittaker Corporation's Greenville, PA site decommissioning plan. A list of the meeting attendees is attached and included your representatives from Scientech, Inc., NRC Region I and Headquarters staff, and representatives from the Commonwealth of Pennsylvania. The meeting was open for public observation but no members from the public were in attendance.

Your representatives from Scientech, Inc. provided an overview of the decommissioning plan, provided estimates of decommissioning milestones, and answered questions from NRC staff and representatives from the Commonwealth of Pennsylvania. Topics included plans for radiological sampling, potential impacts to adjacent properties, estimates of waste volumes and decommissioning costs, and financial assurance.

Your representatives from Scientech, Inc. were able to answer our questions to our satisfaction and we believe the meeting was a productive informational exchange. Your representatives stated that they expect Whittaker Corporation to submit a decommissioning plan for the Greenville, PA site in the Spring of 2002.
