By letter dated October 25, 2001, your staff requested Exxon Mobil Corporation (Exxon) to revise the surety bond and standby trust submitted as financial assurance for decommissioning. We have reviewed a draft of the revision proposed by Exxon in response to your letter. The language of the draft standby trust is acceptable.

Exxon was also requested to revise its surety bond to correct the reference to its NRC license number. A draft of the revised surety bond was not included in the licensee's response.

Please inform the licensee to submit an originally signed standby trust agreement conforming to the language in the draft it submitted. The licensee must also submit an originally signed revision to its surety bond with the correct NRC license number.
