AFFIDAVIT OF DR. RONALD R. BELLAMY CLARIFYING CHANGES IN THE
NRC STAFF'S SCHEDULE

I, Dr. Ronald R. Bellamy, first being duly sworn, depose and state:

1. I am Chief of the Decommissioning and Laboratory Branch, Division of Nuclear Materials Safety in Region 1, U.S. Nuclear Regulatory Commission.
2. My branch is leading the NRC Staff's inspection review of the Fuel Rod Accountability Project (FRAP) for Millstone Nuclear Power Station, Unit 1.
3. The FRAP Final Report was provided to NRC on October 5, 2001.
4. The Staff's onsite inspection of the FRAP report was conducted at Millstone October 9-19, 2001.
5. The licensee's Root Cause Analysis report was provided to NRC on October 31, 2001.
6. Subsequent to the filing of the NRC Staff's Motion Requesting the Licensing Board to Accept Dr. Ronald R. Bellamy's Affidavit Regarding Changes in the Staff's Schedule, the Staff determined that a site visit to GE Vallecitos Nuclear Center (VNC) was not necessary for the completion of its inspection effort, but that some additional inspection review was required. The Staff plans to continue

its inspection review through December 2001.

7. Upon completion of its inspection review, the Staff will formulate its report and make it available to the parties. Based upon the delivery of the Root Cause Analysis Report one month later than anticipated and the need for additional inspection-related activities, I anticipate the Staff's report of the inspection of the FRAP and Root Cause Analysis reports will be completed by approximately the end of January 2002.
8. The matters stated above are true and correct to the best of my knowledge, information and belief.
