The purpose of this modification is to provide incremental funding in the amount of \$47,529.16 hereby increasing the obligated amount from \$80,400 to \$127,929.16 and fully funding the contract. Accordingly, the contract is hereby modified as follows:

Under Section B.2 entitled "CONSIDERATION AND OBLIGATION-TIME AND MATERIALS (JUNE 1988)", paragraph (b) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"(b) The amount currently obligated by the Government with respect to this contract is \$127,929.16."
