

The purpose of this modification is to provide incremental funding in the amount of \$10,847.02 from \$322,441.60 to \$333,288.62. Accordingly the contract is hereby modified as follows:

Section B.2 "Consideration and Obligation-Cost Plus Fixed Fee (June 1988)", paragraph c. is revised to reflect the \$10,847.02 incremental funding as follows:

"C. The Amount presently obligated by the Government with respect to this contract is \$333,288.62."

The amount obligated for this modification is \$10,847.02.

All other terms and conditions remain the same including the contract ceiling of \$333,298.29.
