

The purpose of this modification is to provide incremental funding in the amount of \$85,000.00, thereby increasing the obligated amount of the subject contract from \$985,000.00 to \$1,070,000.00.

Accordingly, the following change is hereby made:

Under Subsection B.18 - **Consideration and Obligation-Work Orders**, the first sentence of Paragraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.18 CONSIDERATION AND OBLIGATION-WORK ORDERS

The amount presently obligated with respect to this contract is \$1,070,000.00."
