

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)							
The purpose of this contract modification is to exercise option year one of the contract. Accordingly, the contract is modified as follows: In accordance with Section I.2, option year one is hereby exercised at the prices set forth in Section B.1 CLIN 0002. The total firm fixed price of the contract is increased from \$64,828.45 by \$161,811.84 to \$226,640.29. Section B.4 is changed to read "The firm fixed price of this contract is \$226,640.29." Section F.2 of this contract is changed to read, "The contract shall commence on June 18, 2001 and will expire on November 17, 2002. The term of the contract may be extended at the option of the Government for an additional three one-year periods." A recap of the funding is set forth as follows: FY 2001 obligations \$64,828.45; FY 2002 obligations \$161,811.84; Total Obs: \$226,640.29. All other terms and conditions remain unchanged.
