Dear Mr. Hopkins:

Because of the considerable savings that are expected from the FirstEnergy merger -- over \$1 billion over the next ten years -- the participants in that proposed merger have been and are endeavoring to expedite the various agency approvals to allow consummation of the merger as soon as possible. In this regard, the participants wish to accelerate the NRC consents required in connection with that merger, and to obtain a conditional NRC consent by June 1, rather than by September 1 as stated in the applications filed on December 13.

We recognize that this accelerated schedule may require readjustment of NRC staff priorities. To minimize any added burden on the staff, we are enclosing proposed federal register notices to obtain public comments and allow the staff to move forward with an initial decision. We ask that the NRC publish these notices as soon as possible, so that any issues that need to be addressed can be idenfied promptly, responded to, and resolved by June 1. Our objective is to obtain by this date the NRC's consent, conditioned on our obtaining other necessary agency approvals, including approval by FERC.

Centerior Energy Corporation is the parent holding company of The Toledo Edison Company, Centerior Service Company, and Cleveland Electric Illuminating Company, which hold the operating license for the Davis Besse Nuclear Power Station.
