This was done to verify the adequacy of Exelon's methodology for scoping and screening and to verify that the activities met the applicable requirements of 10 CFR Part 54. The staff determined that Exelon had performed adequately in developing the methods used for scoping and screening systems, structures and components within the scope of license renewal and subject to an aging management review, pending receipt of adequate responses to the additional information requested.

The staff identified four areas for which additional information will be requested to enable the staff to complete its review of the application. These areas included: (1) a detailed description of the realignment process and the basis for its use; (2) a detailed description of scoping and screening process for mechanical, electrical, and structural systems and components; (3) Exelon's approach to the scoping of Seismic II/I piping systems; and (4) the applicant's approach to Quality Assurance treatment of certain aging management review attributes.
