Dear Mr. Hyland:

We have reviewed the final State of Maine regulations related to Radiation Protection (10-144A CMR 220, Parts A through E, G, and J) which became effective on August 1, 2001. The regulations were sent on June 6, 2001. The final regulations are in response to the 19 amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 19, 20, 30, 31, 34, 35, 36, 39, 40, 70, and 150. We also discussed our review of the regulations with you and Shawn Seeley on May 24, 2001.

As a result of the NRC review, we have identified 13 comments, as enclosed. These comments must be addressed to meet the compatibility and health and safety categories established in Office of State and Tribal Programs (STP) Procedure SA-200.

The SRS Data Sheet summarizes our knowledge of other Maine regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet. D.23.B.	10 CFR 20.1702	1999-3	D/H&S	<p><u>Use of Other Controls</u></p> <p>This section omitted that the licensee may consider safety factors other than radiological factors. Unless the omitted requirement is included, the regulation would not meet compatibility requirements.</p>
D.40.D.	10 CFR 20.2101	1999-3	C	<p><u>General Provisions</u></p> <p>The term "eye dose" is used instead of "lens dose." Unless the term "lens dose" is used, the regulation would not meet compatibility requirements.</p>

The regulation does site FDA criteria but lacks the reference for the FDA criteria.</p> <p>The State needs to either use the labeling criteria established in 10 CFR 32.72 or site the specific FDA reference they are basing the State requirement on.</p>
