SUBJECT: SUMMARY OF DECEMBER 17, 2001, MEETING TO DISCUSS THE STATUS OF WNP-1

On December 17, 2001, the U. S. Nuclear Regulatory Commission (NRC) staff held a public meeting at Rockville, Maryland, with representatives of Energy Northwest to discuss the status of WNP-1. Enclosure 1 is a list of the meeting attendees. Enclosure 2 is a copy of the meeting handouts.

In a May 3, 2001, meeting, Energy Northwest informed the staff that it had commissioned a viability study to determine if it was feasible to complete construction of WNP-1. WNP-1 is a Babcock and Wilcox design whose construction is approximately 65 percent complete. During the December 17, 2001, meeting, Energy Northwest provided the staff with the current status of the viability study. Currently, the viability study estimates it will cost approximately 4.2 billion dollars to complete the unit. Energy Northwest also informed the staff that it had just contracted with Goldschmidt-Imerson to perform an independent review of the viability study and to determine if there was any outside interest in completing the unit. Energy Northwest expects that this effort will be completed in April 2002. The viability study estimates it will take 6 years to complete the unit, with the first year being spent restarting construction and support activities, and then a 5 year period of active construction and startup operations. The staff requested that Energy Northwest let the staff know as soon as possible of any efforts to restart construction.
