Pursuant to the Court's order, the Board of Commissioners of Orange County (hereinafter "Orange County") hereby states that it intends to raise the following issues on this appeal of LBP-01-09 (March 1, 2001), a decision by the Atomic Safety and Licensing Board of the U.S. Nuclear Regulatory Commission:

1. Whether LBP-01-09 violated the hearing requirement of the Atomic Energy Act;
2. Whether LBP-01-09 violated the requirements of the National Environmental Policy Act regarding the preparation of Environmental Impact Statements;
3. Whether LBP-01-09 violated the requirements of the Atomic Energy Act and its implementing regulations for protection of public health and safety;
4. Whether LBP-01-09 violated the Administrative Procedures Act;
5. Whether LBP-01-09 was arbitrary and capricious or otherwise not in accordance with the law.
