Enclosed is a letter from Mr. Joseph Picciano, Acting Director, FEMA Region II, dated November 28, 2001, transmitting the FEMA report for the subject exercise to Mr. Hubert J. Miller, Regional Administrator, NRC Region I.

FEMA determined that the offsite radiological emergency response plans can be implemented and are adequate to provide reasonable assurance that appropriate measures can be taken offsite to protect the health and safety of the public. During the June 6, 2001, exercise, there were no Deficiencies identified; however, there were four Areas Requiring Corrective Action (ARCAs) identified. Three ARCAs were corrected during the exercise or Out-Of-Sequence demonstration. Please provide assistance to offsite officials as they address and resolve any open issues on a timely basis.
