**SUBJECT: SAFETY LIGHT CORPORATION DECOMMISSIONING
COST ESTIMATES AND MEETING COORDINATION**

Dear Mr. Allard:

This letter confirms your support for a joint meeting on January 24, 2002, with representatives from our offices, as well as the Pennsylvania Department of Environmental Protection (PADEP) Bureau of Land Recycling and Waste Management and the U.S. Environmental Protection Agency, Region 3 (EPA). The purpose of the meeting is to develop a shared vision for the future actions for the Safety Light Corporation (SLC) site, as we agreed to during our June 25, 2001 meeting, and as discussed between you and Robert Maiers of your staff and Marie Miller of this office on December 6, 2001. This letter also provides the results and conclusions from our review of the SLC site in Bloomsburg, PA Decommissioning Cost Estimates (DCEs) and Decommissioning Plan (DP). This review was coordinated with our Headquarters office and included PADEP's April 25, 2001 comments on these reports.

The NRC staff analyses and reports from these reviews are described in the enclosed letter to SLC. We believe that your comments were addressed, with the exception of the comment regarding "the licensee not providing a schedule or even an estimate of the time to accomplish major tasks". The licensee's schedule provided a priority or ranking for remediation tasks, if funding were available, and we find them to be acceptable at this time. We would expect a detailed project and health and safety plan before another remediation task was initiated.

Given the significantly larger DCEs and the lack of sufficient funding to initiate any new significant site remediation activities, we need to develop a shared vision and path forward for the SLC site. During this meeting, we would like to explore further PADEP's processes under the Hazardous Sites Cleanup Act. We also plan to hear from EPA staff regarding the EPA's Superfund Program, especially the initiation of a Responsible Party Cleanup and the mechanisms and steps for possible remedial actions at the Bloomsburg site, if it were listed on the National Priorities List.
