
On June 22, 2001, the U.S. Nuclear Regulatory Commission ("NRC") issued an Order approving the transfer of certain interests in Nine Mile Point Nuclear Station Units 1 and 2 to Nine Mile Point Nuclear Station, LLC ("NMP LLC"), an indirect subsidiary of Constellation Nuclear LLC. On October 30, 2001, the NRC issued a Supplemental Order Regarding Approval of Transfer of Licenses and Approving Conforming Amendment permitting the transfer of such interests to occur in two phases, if necessary, namely the transfer of the interests of Niagara Mohawk Power Corporation ("NMPC"), Rochester Gas and Electric Corporation, and Central Hudson Gas & Electric Corporation first, and the interest of New York State Electric & Gas Company, second. It has been determined, however, that the direct transfers of all subject interests can be completed on the same date.

Condition 6 of the Order and Condition 6 of the Supplemental Order require that NMPC provide notification of the date of the closing of the direct transfers no later than two business days prior to such date. In fulfillment of these conditions, this letter provides notice that the closing of the direct transfers is scheduled to occur on November 7, 2001. If you have any questions, please
