Mr. John Lee,

Per our phone discussion a few minutes ago, I am attaching the PDF format version of the Federal Register Notice with the updated fees listing. This was effective on August 13, 2001. I recommend that you discuss the fees questions with Shirley Crutchfield at (301) 415-6097. She can answer your questions about the small entity status, etc. For the table in 10 CFR 170.31, based on the information you have provided, it appears that you would be a category 3H for the exempt distribution license as your device would require review, and your device review would be category 9A. You will also need to contact the State of Maryland for a radioactive material possession license.

Also, as we discussed, Volumes 3 and 8 of NUREG 1556 should provide you adequate guidance in your application preparation for either the exempt distribution license, or the device registration. Section 6 of volume 3 discusses the expected content of your application for the device registration. Section 10 of Volume 3 discusses the details of the content you should provide. Section 10.7 references Regulatory Guide 6.9 for Quality Assurance. I have attached an HTML version of this Reg. Guide for your use.

Please note that there several errors in Section 7 concerning where to send your application. Please use the following addresses in place of those in Section 7:
