**SUPPLEMENTAL INFORMATION TO REQUEST FOR AMENDMENT  
SALEM – HOPE CREEK SECURITY PLAN  
SALEM GENERATING STATION UNITS 1 AND 2  
DOCKET NOS. 50-272 AND 50-311  
HOPE CREEK GENERATING STATION UNIT 1  
DOCKET NO. 50-354**

By letter dated March 5, 2001, (TAC MB1527, MB1728, and MB1729) PSEG Nuclear LLC (PSEG) transmitted a request for amendment to Facility Operating Licenses DPR-70 and DPR-75 for Salem Generating Station Unit Nos. 1 and 2 respectively, and Facility Operating License NPF-57 for Hope Creek Unit 1. The proposed change included:

1. Elimination of the Security Plan provisions that a member of the security force escort all vehicles other than designated licensee vehicles and deletion of the related Security Training and Qualification Plan task on vehicle escorting.
2. Change to the requirement of the Security Plan that all areas of the protected area be illuminated to a minimum of 0.2 footcandle.
3. Change to the required frequency of protected area patrols.
4. Administrative changes to reflect change of the company name from Public Service Electric & Gas Company to PSEG Nuclear LLC.

Per discussions with NRC staff subsequent to the March 5 submittal, PSEG and NRC staff agreed that proposed changes 3 and 4 did not need prior NRC approval and these changes could be made by PSEG pursuant to 10 CFR 50.54(p)(2). By letter dated November 1, 2001, PSEG submitted Revision 17 to the Salem - Hope Creek Security Plan to incorporate the changes being made under 10 CFR 50.54(p)(2).


