SUPPLEMENTAL INFORMATION REGARDING NRC BULLETIN 2001-01, "CIRCUMFERENTIAL CRACKING OF REACTOR PRESSURE VESSEL HEAD PENETRATION NOZZLES"

Ladies and Gentlemen:

The purpose of this letter is to provide supplemental information for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2, regarding NRC Bulletin 2001-01, "Circumferential Cracking of Reactor Pressure Vessel Head Penetration Nozzles." This information was discussed with members of the NRC Staff on November 9, 2001.

HBRSEP, Unit No. 2, will perform a qualified visual examination of the 69 vessel head penetrations (VHPs) during Refueling Outage (RO) - 21 in October 2002. Non-destructive examinations (NDE) of the 69 VHPs will also be performed during RO-21 using a combination of surface and volumetric techniques to assure the integrity of VHPs. A plan for NDE of the HBRSEP, Unit No. 2, VHPs will be provided to the NRC Staff at least 60 days prior to the start of RO-21.

This supplemental information is provided under oath or affirmation in accordance with 10 CFR 50.54(f). Attachment I provides the required affidavit.

Attachment II to this letter provides a summary of information regarding fabrication data for the HBRSEP, Unit No. 2, vessel head penetrations (VHPs).
