Purpose of Meeting: The purpose of this Regulatory Conference is to discuss the risk significance of a potential White finding and associated apparent violation involving detection of radioactive material addressed in NRC Inspection Report 50-445/446/01-07. This finding involved nine examples in which the licensee failed to perform proper radiological surveys to detect radioactivity prior to removing objects from the radiologically controlled area at the facility.
