



Accordingly, the Section III is hereby replaced by the following:

**III. PERIOD OF AGREEMENT**

This agreement is extended to cover the period from October 1, 2000, through September 30, 2002, (FYs 2001 and 2002). Extensions or modifications of this agreement will be executed using the NIH form 1742 Agency Agreement and Clearance or other form mutually agreeable to both parties. Either party may terminate this agreement after providing 90 days written advance notice to the other party.
