

The purpose of this modification is to:

- 1) revise modification number 6 dated 10/17/2001 by correcting the contract ceiling amount;
- 2) under option year 3, decrease the option quantity of item number 6 (Optional Depletion Capability in Monk) by two (2) months from twelve (12) months to ten (10) months, and change the price to \$8,608, per e-mail message received from Ms. Caroline Middlemas, Business Manager, dated 12/20/01.
- 3) exercise the optional CLIN number 6 Optional Depletion Capability in Monk under option year number 3 in accordance with paragraph C.6 52.217-7 OPTION FOR INCREASED QUANTITY--SEPARATELY PRICED LINE ITEM (MAR 1989);
- 4) increases the contract ceiling and obligated amount by \$8,608 from \$295,086 to \$303,694.

Accordingly, the following section of the contract is hereby modified:

1. Under modification number 6 dated 10/17/2001, item number 2 is corrected by deleting entirely item 2 and the following is substituted in-lieu thereof:

"2. As a result of this action, the contract ceiling amount is hereby increased by \$71,495 from \$223,591.00 to \$295,086. Block No. 26 of SF-1449 for this contract is hereby deleted in its entirety and substituted with the following in lieu thereof:

2. Under Subsection B.1 - PRICE SCHEDULE, OPTION YEAR 3 CLIN 6 OPTIONAL DEPLETION CAPABILITY IN MONK is deleted entirely and the following is substituted in-lieu thereof:

6. OPTIONAL DEPLETION CAPABILITY IN MONK	10	MONTHS	\$8,608

3. Under contract clause C.6 52.217-7 OPTION FOR INCREASED QUANTITY-SEPARATELY PRICED LINE ITEM (MAR 1989), the government hereby exercises the optional CLIN number 6 "Optional Depletion Capability in Monk" under option year number 3 at the rate and quantity noted in item 2 above.
4. As a result of this action, the contract ceiling and obligated amounts are hereby increased by \$8,608.00 from \$295,086.00 to \$303,694. Block Numbers 25 and 26 of SF-1449 for this contract is hereby deleted in its entirety and substituted with the following in lieu thereof:
