
Dear Mr. Parris:

1.0 INTRODUCTION

By letter dated December 13, 1984 (TVA #TS-205) the Tennessee Valley Authority (the licensee or TVA) requested amendments to Facility Operating License Nos. DPR-33, DPR-52 and DPR-68 for the Browns Ferry Nuclear Plant, Units 1, 2 and 3. These amendments would delete or modify certain review responsibilities of the Plant Operations Review Committee (PORC).

2.0 DISCUSSION AND EVALUATION

TVA has proposed to delete requirements in Technical Specification 6.2.B.4 "PORC Duties and Responsibilities" for the PORC to (1) review proposed changes to equipment or systems which may constitute an unreviewed safety question pursuant to 10 CFR 50.59, (2) review implementing procedures of the Radiological Emergency Plan and the Industrial Security Program on an annual basis, (the implementing procedures would require only an initial one-time PORC review) and (3) review adequacy of the employer training program and recommend changes.

Proposed changes to equipment or systems which may constitute an unreviewed safety question pursuant to 10 CFR 50.59 are reviewed by the Nuclear Safety Review Board (NSRB) as required by Technical Specification 6.2.A.7.b. The NSRB fulfills the function of providing independent review of operating activities whereas the PORC fulfills the role of onsite review to assist the plant manager. Consistent with Standard Review Plan Section 13.4, (which references ANS 3.2), matters involving unreviewed safety questions are the purview of the independent review organization. Since review responsibility rests with the NSRB change (1) is acceptable.

As indicated in Technical Specification 6.3.B, Radiological Emergency Plan and Industrial Security Program implementing procedures are reviewed and approved by the PORC prior to implementation. Minor changes may be made by selected plant staff members with followup PORC review and approval. Elimination of annual re-review of previously reviewed procedures would have no adverse effect on plant operation or nuclear safety and is acceptable.

The FSAR (13.3.9.3) states that the "effectiveness of training programs is evaluated by the performance of employees in carrying out their assigned duties and by performance on TVA and NRC examinations." In accordance with Technical Specification 6.2.A.8.b the NSRB audits the training of the entire plant staff at least annually. These requirements eliminate the need for PORC review of employee training programs. Since training will continue to be audited at least annually by the NSRB, deletion of PORC review of training is acceptable

3.0 ENVIRONMENTAL CONSIDERATIONS

The amendments involve changes in administrative procedures or requirements. Accordingly, these amendments meet the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(10). Pursuant to 10 CFR 51.22(b) no environmental impact statement or environmental assessment need be prepared in connection with the issuance of these amendments.

4.0 CONCLUSION

We have concluded, based on the considerations discussed above, that (1) there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner, and (2) such activities will be conducted in compliance with the Commission's regulations, and the issuance of these amendments will not be inimical to the common defense and security or to the health and safety of the public.
