Dear Administrative Judges:

Pursuant to Judge Moore's order dated November 15, 2001, and 10 C.F.R. § 2.1231, the NRC Staff is enclosing hereto an index describing and identifying by number the 75 items which make up the initial hearing file in this construction authorization request (CAR) proceeding. Each item contains one or more individual documents (*e.g.*, an item may consist of a cover letter, and one or more enclosures referenced in the cover letter). The items are listed in chronological order, based on the date the item was transmitted between NRC and DCS. Each set of the hearing file is contained in eight notebooks. The 75 items in each set of notebooks are arranged in the same order stated in the attached index. Sets of the notebooks are being mailed this date to counsel for DCS, to Donald Moniak and GANE, and sets are being distributed internally to the Board members. Each notebook contains a cover sheet identifying its contents. To conserve space, some of the larger documents are double-sided copies.
