SUBJECT: ADVISORY COMMITTEE ON THE MEDICAL USES OF ISOTOPES —
RESULTS OF THE OCTOBER 29, 2001, AND THE FEBRUARY 20,
2002, MEETINGS

PURPOSE:

To provide the Commission with the results of the October 29, 2001, and the February 20, 2002, meetings of the Advisory Committee on the Medical Uses of Isotopes (ACMUI).

BACKGROUND:

The ACMUI advises the U.S. Nuclear Regulatory Commission (NRC) staff on issues that arise regarding the medical uses of byproduct material. The Committee provides the staff with information on how its regulations affect the medical community, as well as the treatment of patients.

The Committee members represent diverse areas within the practice of medicine. This broad representation of patient care ensures that NRC receives balanced advice.

DISCUSSION:
