Revisions to Beaver Valley Power Station Emergency Preparedness Plan and Implementing Procedures (Volumes 1, 2 and 3)

The following is a brief summary of the changes made to the Emergency Preparedness Plan/Implementing Procedures.

Emergency Preparedness Plan (Volume 1):

EPP-TOC "Emergency Preparedness Plan Table of Contents"

EPP-4 "Emergency Conditions"

Revision 14 changed the Basis on page 81 from "exceeding >25% LEL" to "greater than explosive concentrations." Also, for EALs 4.3.A, 4.3.U, 4.4.A, and 4.4.U (pages 93-97), the Criterion and Indicator were reworded, and additional basis information was provided. The information and guidance provided in NUMARC/NESP-007 (NEI 99-01) "Methodology for Development of Emergency Action Levels" was used as the basis for these changes.

EPP-8 "Maintaining Preparedness"

Revision 16 clarified the responsibilities listed on page 1.

Appendix G "References"

Revision 5 added two Condition Reports as references.

EPP/Implementing Procedures:

EPP/I-1a "Recognition and Classification of Emergency Conditions"

EPP/I-1b "Recognition and Classification of Emergency Conditions"

Revision 1 (for each) deleted Table 4-2 and Figure 4-B; and added a reference to "Tab 4.2 Explosion" for EAL 4.3 GE and SAE. Also, for EAL Tabs 4.3.A, 4.3.U, 4.4.A, and 4.4.U, the Criterion and Indicator were reworded. The information and guidance provided in NUMARC/NESP-007 (NEI 99-01) "Methodology for Development of Emergency Action Levels" was used as the basis for these changes.

EPP/I-2 "Unusual Event"

Revision 17 added Step "a" to Section 1.5. A previous NOTE was incorporated as a new Step 1.5.1 and Step 1.5.11 was deleted. Remaining steps were renumbered and Step 1.5.12 was added. Corrections were made to the form titles in Sections 1.9 and 2.4.

EPP/IP 1.1 “Notifications”

Revision 28 corrected the form title in Section G.4.0 and in Attachment 4, where the form’s new location is now noted. Attachment 2 was updated to change phone numbers and add FAX and pager numbers. Attachments 8, 9, 10, and 11 each had Steps 7.0 and 10.1 deleted due to equipment changes. Other minor enhancements were also made in Attachments 7, 8, 9, 10, 11, 12, 14 and 16.

EPP/IP 1.4 “Technical Support Center (TSC) Activation, Operation and Deactivation”

Revision 16 split Step 1.4.2 into two steps for clarification and emphasis. A new Task 7 was added on page 1 of Attachment 5 and Tasks 3 & 3.1 on page 3 were deleted. Other minor enhancements were also made in Attachments 1, 3 and 5.

EPP/IP 3.2 “Site Assembly and Personnel Accountability”

Revision 10 revised Step 1.1.1 and deleted Steps 1.1.2 through 1.1.5 since the information is now included in Attachment 10. Other minor enhancements were made in Attachments 1, 2, 7 and 10.

EPP/IP 9.1 “Emergency Public Information Emergency Response Organization Controlling Procedure”

Revision 11 corrected Section D Steps 1.1 and 1.3 and deleted the former Step 1.2. Clarifications were also made to Section E Steps 1.1, 1.3, 2.1 and 3.2.

EPP/IP 9.3 “Activation, Operation and Deactivation of the Emergency Public Information Organization Emergency Operations Facility (EOF)”

Revision 4 corrected Section D Steps 1.1 and 1.3 and deleted the former Step 1.2. Enhancements were also made to Attachment 4.

EPP/IP 9.4 “Activation, Operation and Deactivation of the Joint Public Information Center (JPIC)”

Revision 6 corrected Section D Steps 1.1 and 1.3 and deleted the former Step 1.2. Clarifications were also made to Section E Steps 1.6, 2.1.4 and 2.1.5. Attachment 6 “JPIC News Briefing Summary Sheet” was added. Clarifications were also made to Attachments 1, 2 and 3.

EPP/IP 9.5 “Activation, Operation and Deactivation of the Penn Power Customer Account Services Department”

Revision 6 clarified Section D Steps 1.1 and 1.2. Four steps were deleted from Attachment 1 “Job Guidelines” and Attachment 3 was deleted.
