This is in reference to your application dated December 26, 2001, requesting to amend NRC License No. 06-30423-01. Please note that a new license will be issued because the mailing address has changed from Connecticut to Rhode Island and license numbers are based by the mailing address. We will terminate License No. 06-30423-01 when the new license is issued. The correspondence referenced in License Condition 19 of License No. 06-30423-01 will be transferred to the new license. However, in order to continue our review, we need the following additional information:

Section 8.9 of NUREG-1556, Volume 2 requests information regarding the facility. Since Megarad is moving to Trainer, Pennsylvania, we will need information regarding this new place of storage. Please provide the requested information as described in section 8.9 on pages 8-18 through 8-20 in NUREG-1556, Volume 2 (copy enclosed).
