Afternoon and evening meetings were held to allow maximum public attendance. Presentations were made by Mr. Raj Anand and Mr. Louis Wheeler of the NRC staff. Attachments 1 and 2 are the transcripts, with documents submitted by the public added (one each meeting), for the afternoon and evening meetings respectively.
