Dear Mr. Watford:

By letter dated December 10, 2001, Carolina Power and Light Company submitted an affidavit dated November 6, 2001, executed by you, requesting that the following document be withheld from public disclosure pursuant to Title 10, *Code of Federal Regulations* (10 CFR) Section 2.790:

Global Nuclear Fuel-Americas, L.L.C. Entitled "Additional Information Regarding the Cycle Specific SLMCPR for Brunswick Unit 1 Cycle 14."

A nonproprietary copy of this document has been placed in the Nuclear Regulatory Commission (NRC) public document room and added to the Agencywide Documents Access and Management Systems Publicly Available Records System (ADAMS PARS) Library.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by Global Nuclear Fuel-Americas, L.L.C.'s competitors without license from Global Nuclear Fuel-Americas, L.L.C. constitutes a competitive economic advantage over other companies.
- (4)b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.790 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the submitted documents marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.790(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
