The Nuclear Regulatory Commission has released its Final Environmental Impact Statement on the application by Private Fuel Storage, Limited Liability Company (PFS) for a license to construct and operate an independent spent nuclear fuel storage facility on the Goshute Indian Reservation near Tooele, Utah.
