Dear Mr. Barrett:

The NRC Office of Investigations (OI) initiated an investigation on November 30, 2000, to determine whether an Operations Review Group Investigator (ORGI) was discriminated against by licensee management because he/she contacted the NRC's Indian Point 3 resident inspector regarding a disagreement over a root cause analysis. The ORGI claimed to have been suspended from work without pay as a result of contacting the NRC resident inspector.

Based on the evidence developed during this investigation, OI did not substantiate the ORGI's claim that Indian Point 3 management discriminated against him/her by suspending him/her from work without pay because he/she contacted the NRC resident inspector. The OI investigation, documented in OI Report No.1-2000-044, was completed on July 31, 2001. A copy of the synopsis of the OI report is enclosed.
