This is a follow-up to my letter of February 12, 2001 about the number of on-site inspectors at Indian Points 2 and 3 in Buchanan, New York. Although there is one corporate entity that now owns both facilities, I believe it is important to have the maximum number of inspectors at each locale. Therefore, I would like to see at least two inspectors remain at each plant.

The heavily populated neighboring communities that I represent are concerned about operations, safety, and the threat of terrorism. We all feel vulnerable and want reassurance that your oversight agency is doing the most to help.

I would like clarification from you about the number of on site inspectors at IP2 and IP3 there are today. Will this same number of inspectors be continued throughout the year 2002 and beyond? Please contact me at 914-941-1111. I await your reply.

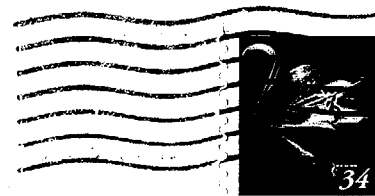
