The purpose of this modification is to exercise the third option period available under the contract in accordance with Section B.01 of the contract. This will be accomplished by extending the period of performance for an additional 12 months and increasing the contract ceiling by \$429,593.00 from \$991,244.00 to \$1,420,837.00. This modification also recognizes the Contractor's change of address. Accordingly, the contract is modified as follows:

1. Block 15G of the Standard Form 26 is changed to read: "\$1,420,837.00"
2. Section I.2, "Ordering (OCT 1995)" paragraph (a) is hereby deleted in its entirety and substituted with the following:

"(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from July 1, 1999, through December 30, 2002."
3. The first sentence of Section F.2 "Duration of Contract Period (MAR 1987) Alternate 4 (JUN 1988)," is hereby deleted in its entirety and substituted with the following:

"The ordering period for this contract shall commence on July 1, 1999 and will expire on December 30, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. The term of this contract may be extended at the option of the Government for one additional 1-year option period."
